Each year companies from all industry sectors across Arkansas provide employees to serve as examiners. The in-depth training examiners receive plus the experience reviewing an award helps improve analytical skills and provides a greater understanding of good business principles. Working with a team of examiners, examiners work individually and collaboratively to prepare a feedback report and determine award level for their assigned applicant. Knowledge gained from training and hands-on experience is value-added to companies who supply examiners.

Examiner Training I for new examiners is March 6 at the Arkansas State Chamber of Commerce. Examiner Training II for all examiners is April 4-5 at Philander Smith College in Little Rock. There is no charge for training if serving as an examiner. Members of the American Society for Quality can receive up to 5 RUs for participating as an examiner.

The *Baldrige Excellence Framework*, a criteria not only recognized nationally but around the world, is designed to help organizations enhance their competitiveness by focusing on two goals, delivering ever-improving value to customers and improving overall organizational



performance. The goal of the Arkansas Institute for Performance Excellence is to see Arkansas organizations improve by offering training, assessment and recognition using our expertise in the Baldrige criteria as the foundation of our efforts.

Training/Assessment/Recognition through the Governor's Quality Award

- Teaching applicants to write an application while self-assessing their processes and results.
- Providing examiners training that increases skills through assessing applications for award and providing feedback while increasing their value to employees who allow them to serve.
- Recognizing excellence in Arkansas organizations that are willing to look at what they are or are
  not doing and how well they do it by answering the questions of the criteria when applying for
  award.

Training industry on topics that affect their ability to perform through AIPE:

- Training manufacturers on the new ISO 9001:2015 standards using its alignment to the criteria;
- Working with healthcare partners to provide the annual healthcare seminar focusing on key issues that affect the healthcare industry
- Cybersecurity workshops using the criteria and the new NIST standard on cybersecurity.

The goals of AIPE will remain the same, but the opportunities with which to achieve them will come through the continued support from our partnerships, selfless work from our volunteers, and development of exciting new ways to extend our reach. Are you in?

#### You Can Still Apply for a 2018 Governor's Quality Award!

Companies and organizations interested in applying for a Challenge level of award may apply through July 1. The first level of the Governor's Quality Award program, the Challenge Award, requires a Key Business Factors Worksheet and a written three- to five-page Organizational Profile. The starting point in assessment, an Organizational Profile gives a better understanding of the context in which you operate, defines key requirements for current and future success, and highlights strategic challenges and advantages. Creating an Organizational Profile helps you understand what is most relevant and key to your organization's primary function, mission and performance. You can leverage your Organizational Profile to begin making improvements for the foundation of your organization.

For manufacturers, creating an Organizational Profile can help in preparation for other accreditation processes such as **ISO 9001:2015 by describing your organizational context**. Using the *Baldrige Excellence Framework* criteria you will answer questions such as: what is your organizational structure; who are your customers and stakeholders; using data and performance improvement. Challenge applicants receive a short feedback report on their Profile.
